*Secretary of the Year Award*

The NCCESA - South Central District, *Secretary of the Year Award* is presented annually to a secretary in the district as a means of recognizing outstanding performance and contribution to the Association and Cooperative Extension. This award is presented by the North Carolina Cooperative Extension Secretaries Association - South Central District.

Guidelines:

1. Nominations for the *Secretary of the Year Award* may be made by any North Carolina Cooperative Extension employee or paid association member.
2. Nominees must be members of the North Carolina Cooperative Extension Secretaries Association for at least five years and must have at least five years service with North Carolina Cooperative Extension.
3. The award will be presented annually at the fall meeting of the NCCESA - South Central District.
4. The secretary selected as a winner will not be eligible to be nominated again for a period of ten years.
5. Nominations must be received by the senior member of the Secretary of the Year Committee by **July 1**. Nominees will be voted on by members of the district with votes going to the senior member of the Secretary of the Year Committee. She will then coordinate with committee members.
6. The winner will receive a plaque and a \$50 cash award. The award will be presented by the previous year's winner.
