DAIRY NEWS September, 2012

I am enclosing a copy of the 2012 Silage Test results from the Alamance County test. I want to thank Williard Dairy for allowing us to have the test plot on their farm. We also want to thank the North Carolina Corn Growers Association for providing funds to conduct the test and the seed company representatives for providing seeds. We also have a grain plot planted on another farm. Hopefully you can use this local data to help you make your decision on corn varieties for next year. Even though our overall corn crop is not going to turn out too good, the silage plot did very well. It had a lot on grain in it and produced some good tonnage.



FEEDING CORN

Our corn crop underwent some pretty severe stress this year so we may be dealing with some aflatoxin issues. Last year we had the same problem. You may want to check the corn you plan on feeding to determine the aflatoxin level. You cannot afford to have high levels of aflatoxin show up in your milk. If you are storing

your own corn, you will need to monitor your bins to prevent buildup of aflatoxin.

You will need to aerate the bin to keep moisture buildup from occurring. The worse thing you can do is put the corn in the bin and forget to check it. Run the fan on cool nights to cool the grain below 55 degrees. Aerate periodically to prevent moisture buildup.

If you grow or buy bulk corn to feed your animals, you can have it tested free of charge by the NCDA at Constable Lab for aflatoxin. Constable Lab is located at 4000 Reedy Creek Road in Raleigh. They need 5 pound sample of whole corn or ground corn. Samples may be mailed directly to the lab at the following address:
