## New Animal ID Rules Effective in March

The Federal Government has issued new rules and regulations regarding animal identification when animals are moved out of state effective as of March 11, 2013. These rules dictate which animals must have official ID to be transported out of state. Below are the most important rules of note to local beef producers. If you have any questions, please contact your local Extension Office or NCDA Vet Division. Please remember that these rules only apply when crossing state lines. If animals are only moved within North Carolina, these rules do not apply.

### #1- Feeder calves (18 months of age or younger) are exempt from official ID.

If you have feeder calves and live in Chesterfield County, South Carolina and typically take them to a livestock market in North Carolina you are exempt from official ID tags on each animal as long as they are under 18 months of age.

### #2.- Cull cows and bulls going directly to slaughter are exempt.

If you live in North Carolina and take animals for slaughter, old cull cows or bulls to a South Carolina plant, they are exempt from official ID requirements.

### #3- All intact males or females, either dairy or beef, moving interstate are under regulations of this law. They must have:

1. Official ID
2. A Health Certificate from a veterinarian listing each animal individually by their ID number.

This is of note to beef producers who may acquire animals from out of state.

If purchasing replacement females or bulls at a sale out of state, the breeder should provide the health certificate and the animal should be tagged.

### **Union County Fecal Samples– May 16th**

#### **Instructions on collecting fecal samples:**

Begin collecting samples today and keep them cool (refrigerated) **DO NOT FREEZE SAMPLES**. Samples will keep under refrigerated conditions for 30+ days. We can evaluate internal parasite levels as well as coccidiosis levels. To take a sample, take a Ziploc bag, turn it inside out, collect the sample, and pull the bag upright to its normal position. Samples should be taken from every group of animals on the farm (heifers, cows, calves, stockers, horses, goats, sheep, etc...).

Collect up to 17-20 fecal samples from each group (if group is 100 + head) of animals on the farm. If the group is smaller than 100 head collect samples from about 10 % of the animals in the group. All together we need no more than a golf ball size amount of 'fresh' manure in each sample bag.

**Place a golf ball size amount of manure in a zip lock bag. Clearly identify each ziploc bag with a familiar name or code. You will need to know what these different samples represent so they mean something to you. Individual ear tag numbers are not necessary.**



## 2013 Norwood Area Value-Added BQA, Preconditioned Feeder Cattle Sales

### Sale Requirements

- Producers must have a current BQA (Beef Quality Assurance) certification.
- Farm must have a premise identification number.
- Calves will be tagged with Value-Added BQA sale tags. For further information regarding tagging cattle for these sales please contact Steve Lemons at (704-983-3987 or steve\_lemons@ncsu.edu) or Bruce Shankle at (704-826-8848 or ebsfarms@windstream.net).
- Calves must be weaned and bunk broke at least 45 days before the sale date.
- Final vaccinations (2<sup>nd</sup> set of shots) must be given at least 3 weeks before the sale date.
- 1<sup>st</sup> set of shots should be given 2 to 4 weeks before Final Vaccinations according to label directions.
- **All heifers will be guaranteed open and traced back to the individual producer via the sale tags if found otherwise. (How the producer decides to guarantee them open is up to his/her individual management decision.)**
- Vaccination records, dates and products must be maintained and provided to the market operator if requested.
- Cattle will be graded, weighed and penned according to grade, weight, breed and sex. **Over filled cattle will not be graded.** Cattle will be graded and sold in truckload lots whenever possible.
- Sire ID recommended, but not required.

### Health Requirements

**All Beef Quality Assurance (BQA) cattle marketed through the Norwood Area BQA sales will follow the preconditioning protocol detailed below.**

#### **Health Requirements:**

- 2 Doses of modified live respiratory vaccine (Bovi-Shield GOLD® 5)
- 2 Doses of clostridial/blackleg (ULTRABAC® 7/Somubac® and One Shot Ultra®)
- 1 Dose of pasteurella vaccine (One Shot Ultra®)
- This dose is administered in combination products in order to reduce the number of injection sites.
- 1 Dose of Haemophilus Somnus (ULTRABAC® 7/Somubac®)

- This dose is administered in combination products in order to reduce the number of injection sites.
- Parasite Control with **Dectomax®** (pour-on or injectable) or **Valbazen®**.
- **\*\*\*All animal health products should be administered according to label directions.**

### Vaccine Schedule Example

#### If 1st Set of Vaccinations is given at Weaning

At Weaning (1st set of shots)	2-4 weeks later (2 <sup>nd</sup> Set of Shots)
<ul style="list-style-type: none"> <li>• One dose of <b>Bovi-Shield GOLD® 5</b></li> <li>• One dose of <b>ULTRABAC® 7/Somubac®</b></li> <li>• Parasite control with <b>Dectomax®</b> or <b>Valbazen®</b></li> </ul>	<ul style="list-style-type: none"> <li>• Booster dose of <b>Bovi-Shield GOLD® 5</b></li> <li>• Booster dose of <b>ONE SHOT ULTRA®</b></li> <li>• Administer Value-Added BQA Tags</li> </ul>

**\*If cattle are weaned and processed for the first BQA sale and held over for the second BQA sale then a third dose of respiratory vaccine is NOT required. The stress and handling of cattle again outweighs the benefits of a third dose if it was administered correctly the first time.**

**\*The 1st set of vaccinations can be administered after the weaning date to allow cattle to settle.**

**#4- All cattle of any age used for rodeo, shows, exhibitions, or recreational events must have official ID and health certificates with each animal listed individually.**

livestock shows. Breed registration numbers will not count as official ID and they must be tagged with one of the four tags listed above.

There are other regulations concerning dairy cows, horses, captive deer, sheep, goats, and swine. For more information or questions, contact your local Extension office or local NCDA Vet Division Tech.
