## COMMUNITY GARDEN LEASE AGREEMENT

1. This agreement is between Guilford County and \_\_\_\_\_ (your name), for the 2020 season, January 1, 2020 – December 31, 2020.
2. The purpose of this agreement is to provide garden plots for public use. Each plot will be 4' by 50' (200 square feet) or 4' by 46' (184 square feet). The rental fee for a season will be \$40.00 for either size plot. A one time \$10.00 deposit will also be collected, to be refunded on completion of fall cleanup to any non-returning gardener. Present gardeners may keep their beds.
3. Each lessee will provide his own seed, tools, and fertilizer per 'Guidelines and Rules'.
4. **Each garden plot holder must contribute 10% of his/her produce to the Community Garden for Share the Harvest.**
5. No plot can be gardened until payment of fees and a signed agreement is received and approved. No exceptions.
6. Each gardener agrees to use the plot and tools at his own risk and agrees to hold Guilford County and its employees, agents, and volunteers harmless from any injury and damage. Gardeners must be 16 years of age or older and have supervision to use power tools. **Proper shoes and safety equipment are required.**
7. This lease may be revoked by Guilford County at any time.
