Paraquat Training

If you are mixing, loading, or applying paraquat, you are required to complete this training every three years.

2023 is the fourth year that this training has been required, so check the date on your certificate to see if it's your year to complete the training again!

Auxin Training

There are three options for auxin training this year.

- **OPTION 1:** Live Zoom Trainings

Respirator Fit Testing -BFMA Contract with Plymouth Primary Care

The BFMA has recently signed a contract with Plymouth Primary Care, allowing members (and employees of members) to receive respirator fit testing at a discounted rate. You can call and set up your appointment at a time that works for you!

- Medical Clearance Form \$10
- Fit Testing \$30

Other services offered at a discounted rate:

- DOT Physical Exam for CDLs \$99
- Urine Drug Screen \$45
- EKG \$50
- Purified Protein Derivative (the Tuberculosis test) \$19
- Hearing Test \$45
- Random & Pre-Employment Drug Screens \$45

Some things to note:

- Plymouth Primary Care asks that you make your appointments in advance by calling 252-793-4135.
- Let them know that you are a BFMA member and what medical service you need.
- Under this contract, Plymouth Primary Care does not accept insurance and asks that you pay up front or give an address for direct billing (farm address is fine).

Not a BFMA Member? You still have options:

- There will be a few fit testing clinics offered by Extension in the area. More information will come when dates are set
- The Hyde County Health Department is offering respirator fit testing January March. Call 252-926-4399 to set up an appointment.
