Requirements for Participation of Home Raised Calves:

- All MCA cattle must be processed according to NC Beef Quality Assurance guidelines.
 Participants should be NC Beef Quality Assurance certified, or they can be aided by a certified
 NC Beef Quality Assurance extension agent or another producer.
- 2. All cattle must be home raised.
- 3. Cattle must be weaned a minimum of 60 days prior to delivery.
- 4. Animal Health Program (Merck PrimeVAC 45 Protocol)

Safeguard Drench

Injectable Dewormer (Producer's choose)

Implant (either Ralgro or Revalar G)

MCA ear tag in right ear.

- 5. Vaccination protocol must be completed 21 days prior to delivery.
- 6. MCA calves are identified with an MCA custom tag in calves' right ear. Steers are tagged with green tags, Heifers with a yellow tag.
- 7. Weaning weights are required for WNCRLC to project loads.
- 8. Heifers are Guaranteed Open.
- 9. Bull Guarantee, Males must be castrated and healed preferably at a young age.
 - <u>a.</u> Cattle sold be castrated and healed before first working. Knife castration is strongly recommended.
 - b. If banded, scrotal sac with two testicles must have fallen off and completely healed.
 - <u>c.</u> Improper banding technique may lead to stags; late castration calves will carry a bullish appearance. Both are hugely discounted and may be rejected.
- 10. Sellers agree to reimburse buyer's \$200.00 for heifers and intact bulls/stags. A veterinarian must properly verify all claims from purchaser within (4) months of delivery date.
- 11. Calves require Dehorning and healed (no visible horns or scurs)
- 12. MCA producers are encouraged to practice low stress cattle handling. Cattle with bad dispositions and temperament are <u>NOT</u> desirable in any aspect of the cattle industry. It is important that we continue our reputation for docile cattle.

13. Feeding program:

- a. Trained to eat feed from a bunk and drink water from a trough
- b. Calves should not be over fed; fleshy calves should be avoided and are likely to be discounted.
- c. Calves should gain 2 to 2.5 lbs. per day during the preconditioning period.
- d. All calves are to be to be fed a formulated diets to produce similar rates of gain.
- e. No feed supplements will be composed solely of corn gluten pellets.
- f. Calves must have access to free choice mineral supplements. No other salt available.
- g. Calves that are overly full on delivery day Will Not be tolerated.
- 14. The following cattle listed **Do Not** qualify for the MCA criteria:
 - a. Number 2 and number 3 muscle cattle.
 - b. Small frame or excessively large frame cattle.
 - c. Rat tail calves.
 - d. Dairy cross, Brahman Influence, Feather neck Hereford, Pink nose Charolais or double muscle cattle.
- 15. Cattle that have the following defects or abnormalities Will Not be accepted:
 - a. Unhealthy or animals with abscesses.
 - b. Late cut bulls or stags
 - c. Cattle with excessive warts, bad eyes, lameness, calves with ringworm, defective ears, tails, humpbacked cattle or calves with excessive hair coats.
- 16. All cattle will be inspected and any animal that does not meet sale requirements will not be eligible for the MCA sale.
- 17. All calves will be sold with the standard cattle industry 2% shrink and topside slide.
