2024 High-Country Pullet Project Contract

Contract Terms:

- Youth participants in the High Country Pullet Project agree to the following:
 - a. Participation Fee (\$50) due by May 1st. For families with multiple children, each additional child in the program has a discounted participation fee of \$15.
 - b. Youth are expected to be in attendance at all workshops (including the Madison County Fair)
 - April: General Animal Care @ Your County Extension Office
 - April 15th @ Madison County Extension Office
 - April 22nd @ Yancey County Extension Office
 - May 1st: Participation Fee Due to your County Extension Office
 - Week of May 20th: Adoption & Scheduling Site Visits for First Time Participants @ Madison Extension Office
 - June 24th: Chicken Trivia & Eggcellent Egg Contest Preview @ Yancey Extension Office
 - July 29th: Handling & Washing @ Yancey Extension Office
 - August 26th: Showmanship & Mock Show @ Madison Extension Office
 - September 23rd: Project Record Books @ Your County Extension Office
 - September 26-28th: Madison County Fair Show
 - September 30th: Program Completion Celebration @ Yancey Senior Center
- *If youth must miss a workshop due to illness, or family reasons, they must contact their county Agent to make arrangements ahead of time. If youth miss a workshop, it is their responsibility to make-up the missed content with their county Agent.
- c. Youth must show in the Madison County Fair. There will be an opportunity for participants to win show premiums (estimated at \$100+) for the quality of their bird and showmanship skills.
- d. Youth must properly care for their animals. If improper care is observed during workshops, immediate, additional site visits will be conducted. If improper care is still occurring, youth may be terminated from the program, deposit will be forfeited, and animals will be confiscated.
