Kristin Davis provided the educational program highlighting local foods.

Minutes of the June 11, 2012 meeting were approved.

REPORTS:

County Extension Director Robert Furr provided an Extension Administration update.

- 1. Catherine Crocker was introduced as the new 4-H Program Assistant. She began work on July 30. Catherine will manage all volunteers that work through 4-H. She will also manage traditional 4-H clubs and work with other special interest 4-H programs.
 - The new 4-H Agent has been hired and will start work on Tuesday, September 4.
- 2. Plans for the kitchen have been approved. Permits have been issued. Construction is scheduled to begin in September. The kitchen construction may be done in phases, depending on the final cost.
- 3. NC General Assembly approved a 1.2% salary increase for state employees. Cooperative Extension staff will receive their salary increases in the next month's check.

1. Reviewed summer camps. Six day camps run through Park and Recreation used 4-H curriculum. Nine teens attended 4-H teen congress. Fifty nine teens attended Shelton Leadership Challenge. Twenty-seven youth attended residential 4-H camp.

Scott Ewers shared horticulture program highlights

Horticulture

- 2012 EMG training complete twelve new interns will begin their initial 40 hrs of volunteer service.
- 2013 EMG Winter Training will start in Jan. So far 23 applicants have received notification that they are invited to be trained as Master Gardeners.
- Planning is underway for 2013 Pesticide/Landscape seminar. CGIN is looking into using the Union County Agriculture Center for the seminar. The change in venue will save the association over \$4,000 dollars in expenses.



Family & Consumer Science

Program Update:

Better Food, Better Health Latino SNAP-Ed Program - Better Food Better Health (BFBH) is a nutrition, food resource management, and exercise program for Latino adults and families. The program, offered in both English and Spanish helps families learn and develop healthy lifestyle choices while enjoying quality time together.

The FCS program has joined the 2013 grant year for SNAP-Ed. Mecklenburg FCS will provide BFBH programming to 15 Mecklenburg Latino families in 2013.

From Farm to Fork: The Journey to your Plate=The FCS program will present interfaith workshop exploring the local food system on November 3, 2012. The program is a collaborative effort of New Beginning Moravian Church, Mecklenburg Extension and surrounding Huntersville congregations. The workshop will introduce participants to the local food systems and available resources in their area and beyond.

National Food Day 2012 in Mecklenburg

The Mecklenburg Family and Consumer Sciences agent will serve as the Charlotte Area coordinator for Food Day 2012. The responsibility will include bringing together local agencies with an interest in local foods to host an array of educational and advocacy events supporting local foods. The focus of this year's synergistic celebration is: "Education on real, local, wholesome and unprocessed foods". The following agencies are currently participating in National Food Day:

Parents' Night Out/Film Screening: Parents' Night Out is an event to energize and educate parents to support local, healthy and wholesome food for their families. The event will include a film screening of Food, Inc and a special guest presentation from Lisa Leake of 100 Days of Real Food, a famed food blogger who has garnered national attention. Lisa will share her families experience and tips on how to infuse family diets with fresh and wholesome foods. The event is a partnership of Mecklenburg Cooperative Extension, NCPTA, Youth Empowered Solutions, EarthFare and Cabot Cheese.

Family & Consumer Science (cont.)

• "La Vida Local: A Celebration of Real Food": La Vida Local is a culmination celebration of National Food Day for Mecklenburg County. The celebration will feature a local food showcase of 7th St. Market vendors, area local food purveyors and local food advocacy agencies. Guests will have an opportunity to network during a 1.5 hour happy hour. A panel presentation and chef demonstration will follow featuring local food experts and ingredients from the region. The event is a partnership of Mecklenburg Extension FCS, Charlotte Center City Partners and the 7th St. Market.

Fresh Expo: The Mecklenburg County Coop. Ext. has received an opportunity to prominent presence at the Charlotte Fresh Expo. Kristin Davis will speak on the main stage and raise awareness of Cooperative Extension as a local food resource and educational resource. Meck CES will also have a large display area which will be shared with key community partners. The platform will provide national recognition of Mecklenburg County Cooperative Extension.



NC 10% Campaign Update- Mecklenburg County

The 10% Campaign is a statewide collaborative initiative led by the Center for Sustainable Farming Systems (CEFS) and North Carolina Cooperative Extension promoting locally grown food, farmers and the businesses and people who grow, prepare, distribute and sell food in North Carolina.

Goal: Encourage individual and business consumers to commit 10% of their existing food dollars on locally produced foods.
