

# 2021 West District 4-H Qualifying Horse Show May 1<sup>st</sup> and 2<sup>nd</sup> – WNC Agricultural Center Registration Packet

We are happy to announce the 2021 West District 4-H Qualifying Horse Show. The show will be on Saturday May 1<sup>st</sup> and Sunday May 2<sup>nd</sup> at the WNC Agricultural Center in Fletcher, NC. Enclosed you will find the information needed to register for classes, request stalls and determine your riding division. We hope that you choose the beautiful mountains of Western North Carolina as your location to show at a District 4-H Show and to qualify for the 2021 NC State 4-H Horse Show.

Here is some important information you will want to know:

#### **Registration Deadline:**

The West District 4-H Qualifying Horse Show requires pre-registration to avoid a \$25 late entry fee. A registration packet is only complete if it has all the required items included and postmarked by April 12<sup>th</sup>. Please double check that all of you required items are included in your registration. Packets that do not have all of the required items included by April 12<sup>th</sup> are considered late and charged a \$25 late fee. You may add up to three additional classes the day of the show. The following items must be in your completed registration packet:

Qualifying 4-H Horse Show Entry Form

4-H Eligibility Card (send a **copy** with your entry and bring the original for check-in)

Coggins (send a **copy** with your entry and bring the original for show check-in)

Stall and RV Reservation Form

Consent, Release and Waiver of Liability Form

NC 4-H Photo & Media Release (show will be live-streamed and you must sign to show)

Check or money order with the 4-Her's name noted (**Do not send cash**)

Reminder: the horses name must be the same on the entry form, Coggins and Eligibility Card Any entry that does not have these items included and postmarked by April 12<sup>th</sup> will incur a \$25 late fee. **Patterns for classes** will be posted two weeks before the show on the NC State Equine Husbandry website under Qualifying Horse Show information.

#### **Covid-19 Safety Protocol**

This year we will work to keep our participants, families and volunteers safe by abiding by our State 4-H Livestock Safety protocol. We need your help to make sure that our show can precede with everyone feeling safe and protected

- The first time you enter the facility each day we will check your temperature and ask that you wear a wristband showing that you have had a temperature check
- Everyone on the grounds will be asked to wear a mask unless they are mounted

- Youth in in-hand classes and walking to and from the arena will be asked to wear a mask
   so please familiarize your horse with what you look like in a mask
- We will stream classes on-line for family members to watch each rider must sign the NC 4-H Photo & Media Release to be able to attend this show.
- Our main arena will be live streamed for family and friends to see at http:go.ncsu.edu/westdistricthorse

#### **Eligibility Card and Coggins**

Each entry must include a copy of your 2021 4-H Eligibility Card with the signature of your 4-H Agent and club leader. Please check with your Agent for help with Eligibility Cards. The horse's name on the Eligibility Card must match the name of the horse entered. Please include a copy of your current negative Coggins. Please do not mail your original Eligibility Card or Coggins. We must see your original as you check in upon arrival. There may be a State Veterinarian present during the weekend checking coggins at the show. Please be polite and provide your documents if asked. If you have an emailed or digital coggins test, please have a printed, color copy to show.

#### **Shavings, Stall Fees and Grounds Fees**

Shaving will be available for a fee of \$8.00 per bag. Please note on your registration form the number of bags that you would like to purchase. You are also welcome to bring your own shaving for you stalls. Stall fees are \$40.00 per stall for both horse stalls and tack stalls. There is only one stall fee for the whole weekend, no matter which day you check in. Please note the number of stalls you would like on your registrations form. If you are showing out of your trailer there is a \$15.00 per horse/per day fee. All horses staying on grounds overnight must have a stall and appropriate bedding. All youth staying on grounds overnight must have an adult chaperone.

#### **Check-In and Stall Assignments**

Check in will be at the small blue barn on Friday April 30th from 6:00pm – 8:00pm and on Saturday from 7:00am until 3:00pm. If you need check in at a different time, please call Tammara at 828-273-0860. You will receive your stall assignments prior to the show. If you have a special stall request, please note it on the bottom of your registration. County stall assignments will be blocked together. Only horses showing will be allowed on show grounds.

#### **Show Rules**

It is the responsibility of the exhibiting 4-Her and their family to be aware of the rules. Please read over this entire packet and the current NC State 4-H Horse Program Rules and Regulations Manual. It is value to look at not only to know the rules but it explains the different division and classes in detail. The address:

One important rule to remember at 4-H Horse Show events is that there are to be no adults on horses for the entirety of the show. For this show, there are to be no adults on horses from the time that the horse arrives at the show facility until they return home. Any adult riding a horse at the West District 4-H Qualifying Horse Show will disqualify that horse from being able to compete for the entire show.

#### **Sponsorships**

Please help us sponsor the 2021 West District 4-H Qualifying Horse Show! Attached is a sponsorship form to help gather sponsors for our show. This is a great opportunity for your area horse services and horse suppliers to market their businesses to a large number of horse families at one location. Sponsorship helps you too! For any sponsor you collect and postmark by April 12<sup>th</sup>, we will credit your entry fee with 20% of the sponsored amount. They must be postmarked by April 12<sup>th</sup> to be in our program and to receive a printed banner. Attached is a sponsorship letter and sponsorship form. Please mail the form back in with your sponsors check.

#### Judge's Decision

The decision of the judge is final. All horse and ponies cannot win, so the judge's decision, whatever it may be, should be accepted in the true spirit of 4-H sportsmanship. When an exhibitor, parent, leader or agent is guilty of unsportsmanlike conduct, the show management has the right to suspend that exhibitor's right to participate in future classes or shows. The person exhibiting this behavior can and will be barred from the show grounds for unsportsmanlike conduct or improper behavior.

The following point system is used in earning qualifying points toward attending the State 4-H Show and for Division Placing. Each exhibitor and horse must earn one or more qualifying points in their division to be eligible to compete at the NC State 4-H Horse Show.

#### **Class Age Groups**

Cloverbud: Ages 5-7. These riders will not be placed against each other but will receive a ribbon for their class.

Saddle Seat Academy: These classes will be walk-trot only and cannot be cross entered with other Saddle Seat Classes

Short Stirrup: Riders must be ages 8-13 as of January 1<sup>st</sup> of the current year. Three years participation in the division is allowed, with no more than 2 years showing over fences. (Hunter Hack does not count towards the 2 years over fences and may be shown all 3 years.)

Rookie: Riders in their first year of showing Hunt Seat as a Junior or Senior as of January 1<sup>st</sup> of the current year. Riders are permitted 1 year to show as this level.

Long Stirrup: Riders must be ages 14-18 as of January 1<sup>st</sup> of the current year. Two years of participation in the division is allowed. Riders in this division may not have previously shown over fences for more than 2 years.

Little Britches: Riders must be ages 8-13 as of January 1<sup>st</sup> of the current year, who are in their first 2 years of showing. Riders in this division cannot cross enter in the Junior Western or Junior Ranch Divisions.

Junior Riders: Youth who have not reached the age of 14 as of January 1<sup>st</sup> of the current year.

Senior Riders: Youth who have reached the age of 14 as of January 1<sup>st</sup> of the current year and have not reached the age of 19 as of January 1<sup>st</sup> of the current year.

#### NORTH CAROLINA 4-H YOUTH DEVELOPMENT PROGRAM LIABILITY WAIVER, ASSUMPTION OF THE RISK, PHOTO & MEDIA RELEASE, AND INDEMNIFICATION YOUTH AGREEMENT

In consideration of NC State University and/or NC A&T State University allowing my minor child to participate in the North Carolina 4-H Program, (hereinafter "Program"), I, for myself and/or on behalf of the minor child listed below ("Minor"), agree as follows:

I affirm and acknowledge that the Minor is participating in the Program for their own personal benefit. I understand that the Minor will participate in recreational and other activities as part of the Program and that such activities have inherent dangers and physical risks. I understand and acknowledge that the inherent dangers and physical risks involved in these activities are such that no amount of care, caution, instruction or expertise can completely eliminate them. These dangers and risks include, but are not limited to, loss of or damage to personal property, strains, sprains, bruises, heat exhaustion, and other personal injuries, or even death, that could result from tripping, falling, contact with other individuals, and equipment failure, among other causes. I assume responsibility for all risks, known and unknown, involving the Minor's participation in the aforementioned activities, and I voluntarily authorize the Minor's participation in reliance upon my own judgment and knowledge of the Minor's experience and capabilities.

Additionally, I understand that the coronavirus ("COVID-19") has been declared a worldwide pandemic by the World Health Organization and has become more widespread, including within North Carolina. COVID-19 is very contagious and believed to be spread mainly from person-to-person contact. I understand and appreciate that there are known and potential dangers of utilizing the Program's facilities, services and programs, and I acknowledge that the use of these facilities and services may, despite the Program's reasonable efforts to mitigate the dangers, result in exposure to COVID-19, which could result in quarantine requirements, serious illness, disability and/or death. The Center for Disease Control and state and local health departments, are reviewing and updating their respective guidance on the pandemic and its impact nearly every day.

I represent that I am acting on my behalf or as the parent or legal guardian of the Minor and I have authority to enter this Agreement. I also represent that the Minor is in proper physical and other condition to participate in the Program.
