# **2009 NC Broiler Supervisor's Short Course**

On August 20, the service tech personnel from the main integrator broiler companies with business in North Carolina participated in the 2009 NC Broiler Supervisor's Short Course. This is an annual event that has been held at the McSwain Extension Center in Sanford, North Carolina. This year the program included talks related to alarm systems and auto start generators for disaster prevention in broiler houses; value of ventilation for high yield broilers; processing plant issues and its relationship with management and handling of broilers; feed quality at the farm and impact on broiler performance; tips and considerations for successful farm vaccination; litter management, and windrowing systems for litter management. The panel of speakers included Mr. Richard NC State University Currin from Laboratories, Mr. John Blakely from Aviagen Inc., Dr. Doug Smith and Dr. Charles Stark from the Department of Poultry Science at NC State University, Dr. Andy McRee from Lohmann Animal Health International, Mr. Blake Gibson from Jones-Hamilton Co., and Mr. Alvaro Villaveces from NIPCAM Inc. ## Poultry Presentations and Judging at NC Annual 4-H Congress

#### **NC State Fair Youth Market Turkey Show**

Over 300 youth across North Carolina received turkey poults from the Department of Poultry Science in late May. As always, advance registration was required and the contest is so popular that in less than 48 hours we had filled all 300 spots and began a waiting list! Poults were donated for the 2009 show by Prestage Farms and we thank them for their continued support of this popular program. This year we will be having a Hen show instead of a Tom show on Oct. 16<sup>th</sup> at the NC State Fair due to a disease problem in the first week with our toms. We are expecting a slightly smaller show than the last two years which had over 200 youth bring full grown birds back. Not everyone was available to come and get the hen poults in June when we did our redistribution but we are so happy that we were able to get additional poults and to keep the show going this year. Youth will bring their best Hen to the fair on Wednesday Oct. 14<sup>th</sup> for check-in. They will need to bring their "green receipt" with them for proof of registration and to make everything flow much smoother. Check in takes less than 5 minutes as we simply band the bird, record the weight and file the paperwork. Agents, teachers or parents may check birds in on the contestant's behalf if they are unable to make it. We will be checking in birds from 10:00 until 6:00 p.m. on Wednesday the 14<sup>th</sup> at the poultry tent and then will create our classes by age for the show that will begin on Friday at 9:00 a.m. If you would like to know more about our turkey show, please visit

# New Guidelines on Mass Mortality Composting

In a September 2008 article "Developing a Farm Plan for a Mass Poultry Mortality" we discussed all of the options for contract poultry growers for disposing of mass mortalities. One of the options is to compost a mass mortality. If a grower has a full house of chickens die, he/she will either have to compost it inside of the house or outside of the house in windrows. The State Veterinarian's office recently developed a policy on how a grower can compost a mass mortality outside and the process for getting it approved.

Below is the actual policy that was issued on March 27, 2009 by the State Veterinarians office.

Alternative open composting of large numbers of carcasses following an emergency mortality event may be allowed if permitted by the State Veterinarian's office. Permission for windrow or static pile composting may be allowed under the following conditions:

- 1. Open composting must be conducted in accordance with Natural Resources Conservation Service (NRCS) Conservation Practice Standard Code 316; Animal Mortality Facility (attached) and also available at <a href="http://efotg.nrcs.usda.gov/references/public/NC/nc316-nov2005.pdf">http://efotg.nrcs.usda.gov/references/public/NC/nc316-nov2005.pdf</a>.
- 2. A suitable site is chosen for the composting that meets all federal, state and local rules and regulations for buffering the site from streams, lakes, wetlands, property lines and other features. The site must be no closer than 100 feet from wells, springs or water courses, and a minimum of 300 feet from neighboring residences. It must be 100 feet from all property lines. Considering the prevailing winds in the area, the site should be located downwind from populated areas. It should not be located within a 100 year floodplain. In addition, it should be located on a well drained site. It is recommended that the owner should work with NC Department of Environment and Natural Resources (DENR) or the Natural Resources Conservation Service (NRCS) to preselect a site that would be suitable in the event of catastrophic mortality. Available space should allow an area 30 feet wide, variable in length and including a staging area for equipment.
- 3. If open composting is permitted by the State Veterinarian's office, the compost product must be spread on the owner's property or property associated with the owner's farming operations.
- 4. The windrow or pile must be constructed in such a way as to control excessive odors and prevent rodent, vermin or insect activity. The pile or windrow should be capped with at least a 2 foot layer of wood chips, sawdust or other carbon source and have an 18 inch to 2 foot base of similar material.
