As I've mentioned before, we've experienced \$20 million in permanent state and federal budget cuts since 2000, resulting in the loss of numerous field faculty, administration, support, and faculty specialist positions both on campus and in the counties. This thorough review of our business model, and any subsequent change, is a necessity.

The initiative is marching forward as we identify the most valued programs and services that will meet the needs of North Carolina citizens and businesses during our next 100 years. Since the effort was first announced in a memo from me on September 25, 2013, we've made significant progress thanks to the time and dedication of our employees, local governments and other valued partners and stakeholders.

I must reiterate our sincere appreciation to all of those who have gotten us to this point; your participation and passion have been inspiring. To quote one of the greatest leaders the world has ever known:

LISTENING SESSIONS: LOUD & CLEAR

We recently wrapped up a series of 14 public listening sessions in addition to the State Extension Conference employee session in November. These sessions took place over a six-week period at locations ranging from Plymouth on the coast to Bryson City in the mountains. Nearly 2,000 employees, volunteers, elected officials, ag producers, and other interested citizens participated!

Visioning Team Meetings and Plan Development – The Visioning Team, comprised of Extension employees and representatives from partnering organizations, local governments and community groups, will begin analyzing stakeholder feedback in a focused meeting the week of January 20, 2014. The team will meet over the course of three days in January and February and throughout the spring to review the input provided and other data. They will evaluate your needs, concerns and ideas in order to craft a recommended plan and strategy for moving forward, which we plan to reveal in May 2014.

Public Announcements & Updates – We plan to distribute another news release to state, regional and national media outlets providing an initiative update in January 2014. This external awareness campaign will consist of media relations, social media outreach and Extension promotion. We will also share the announcement with you via our listservs, websites and other online resources.
